We are neither producer nor importer of substances which require mandatory registration.

In this table, you find two of our standard mass finishing applications:

AISE-P1010 => Surface finishing; manual process without process water recycling
AISE-P1011 => Surface finishing; manual process with process water recycling

Therefore, we assume, that these applications („intended use“) will be supported on behalf of the raw material producers for the registration of these substances in our raw materials.

Actually, we do not expect any impairment of our supply availability of mass finishing consumables.
